

Special Notice for Ohio Residents

On July 2, 2018, the State of Ohio began issuing an Ohio interim Identification form while the new permanent Driver's License and Identification card is being processed and mailed (within 10 business days).

For passport purposes, the Ohio Interim Identification form is considered a supplemental identification. If you do not have an acceptable primary identification document, you may submit secondary/supplemental identity documents or, if possible, await the arrival of your new permanent Driver's License.

Montgomery County Auto Title Division How To Apply for Your U.S. Passport <u>Regular Processing</u>

WHAT TO BRING

1. Proof of Citizenship - Provide <u>ONE</u> of the following:

- A certified birth certificate from the country or state in which you were born
 - The birth certificate must have a raised, embossed, impressed, or multicolored seal, and it must list both parents. Hospital certificates, photocopies, and electronic certificates are not acceptable.
- A naturalization certificate
- A certificate of citizenship
- A full-term, non-limited U.S. Passport book or card (undamaged)

2. Proof of Identity (Photo Identification)

• A valid state or federally issued picture ID such as a driver's license, ID card, military ID, or passport book or card.

3. Passport Application Form - First-time applicants:

 A passport application (form DS-11) for first-time applicants. You should complete the form before coming to the Passport facility, but <u>do not sign the form</u> until you meet with an agent.

4. Passport Photo

We provide passport and visa photo services on site.

5. Payment of Fees - Cash, Check, or Money Order (Credit Cards only on Clerk Fees)

- You will pay *TWO* separate fees: a passport application fee and a Clerk Fee.
- Bring a *check or money order* made out to the U.S. Department of State for your passport application fee.
- Bring a separate check, money order, cash, or credit card for the Clerk fee.

WHAT TO BRING

1. Proof of Citizenship - Provide <u>ONE</u> of the following:

- A certified birth certificate from the country or state in which you were born
 - The birth certificate must have a raised, embossed, impressed, or multicolored seal, and it must list both parents. Hospital certificates, photocopies, and electronic certificates are not acceptable.

June 24, 2025

Priority Mail Express Fee Increase Effective June 27
